

MANCHESTER UNITED SUPPORTERS' CLUB : BOOKING FORM: TOUR 2010

We have secured a limited number of tickets to United's Premiership match versus **STOKE CITY**, which takes place at Old Trafford on **SUNDAY 9TH MAY 2010**.
The tour departs Johannesburg International Airport on **WEDNESDAY 5TH MAY** and returns from Heathrow on **WEDNESDAY 12TH MAY**.

The price of **R13,500 pps** includes return airfares ex Johannesburg International, luxury coach transport, 6 nights B&B accommodation (4 Manchester, 2 London), match ticket, a tour of the stadium and museum, a visit to the training ground (with the Manager's permission), and lunch at the Red Café. Cost is based on the prevailing exchange rate and any dramatic increase would result in such increase being passed on to travellers.

Airport taxes are not included in the rate, and will be billed separately prior to departure. Breakfast will be provided in the hotels, but all other meals and personal items are for the individual's expense.

Kindly note that coach transport will be provided between London and Manchester, to Carrington Road training ground, between the hotel and Old Trafford, and back to London. Should any extra use of the coach be required for whatever reason, cost will be divided among the passengers travelling. Also, should tour party members agree upon any other events, cost is for the individual's expense.

A non-refundable deposit of **R4,000** is required as soon as possible to secure your place. Payment may be made by cheque, or alternatively, direct payment into the Club's bank account, with the deposit and application form faxed to me. Passengers will be invoiced for the balance owing on 1st February 2010 and said balance will be due **in full** by 28th February 2010. A levy equal to 10% of the outstanding balance owed will become due on late payments. **There will be no exceptions!!**

This booking form must be signed as acceptance of the terms and conditions as listed overleaf. Bookings will only be confirmed on receipt of the required deposit and this acceptance,

CONDITIONS OF CONTRACT - THE SMALL PRINT

- All reservations are confirmed on the condition that a non-refundable deposit is paid to Manchester United Supporters Club within 14 days of confirmation. The balance owing must be paid by the date stipulated but not less than eight weeks prior to departure. Prices are quoted at the ruling daily rate of exchange, and any dramatic increase would result in such increase being passed on to travellers.
- Until full payment is received, we reserve the right to alter any variations to the passenger's account. **We reserve the right to cancel any reservation held in respect of which payment is not made timeously.** The onus will be on the passengers to check there have been no changes in price prior to making final payment. An amendment fee will be levied to cover any alteration fees once the reservation has been confirmed.
- **One United Membership is a requirement and should any passenger not be a 2009/10 One United Member he/she will be required to pay the prescribed fee in addition to the quoted cost of the tour.**
- Amendments to confirmed reservations will be processed at a fee of R1000 for each alteration to be made after the initial reservation.
- While every effort is made to keep all published itineraries we reserve the right to make changes for your convenience. **No refund for unused services – including accommodation - will be considered.**
- In the event of passengers cancelling their reservations Manchester United Supporters Club shall have the right either to claim the total amount of any deposit paid by such a passenger or to claim any damages suffered by the branch. In accordance with the policy adopted by tour operators throughout the world, Manchester United Supporters Club reserves the right to cancel any trip before departure, in which event the entire payment will be refunded without any further obligation on the part of the branch. The following cancellation fees may be imposed unless otherwise stated:

From time of booking until 8 weeks prior to departure: Deposit forfeited
8 weeks prior to departure: 25% of the tour price
6 weeks prior to departure: 50% of the tour price
4 weeks prior to departure: 100% of the tour price
- Insurance against cancellation, illness and for the loss of baggage is highly recommended for all passengers travelling. Passengers are responsible for their own insurance and Manchester United Supporters Club will not be liable should anyone fail to take out sufficient insurance cover.
- Travel documents (tickets, itineraries, etc.) are only prepared on receipt of full and final payment and signed conditions of this contract.
- The responsibility to obtain proper, current and valid passports is that of the passenger alone, and Manchester United Supporters Club will not be responsible or liable for any consequence of any nature arising from the passenger failing to ensure all requirements are complied with.
- In the unlikely event of there being an unscheduled extension to the holiday caused by flight delays, bad weather, strikes or any other cause which is beyond the control of Manchester United Supporters Club it is understood that the expenses relating to these unscheduled extensions (hotel accommodation, etc.) will be for the passenger's account.
- Whilst it is possible to break away from planned holiday itineraries, it is understood that extra expenses incurred as a result of such breakaways will be for the passenger's account.
